Dear Friends,

KEEN emerged from the pandemic ready to serve our community better than ever. We are proud to report that, despite the financial challenges we all faced last year, KEEN grew, developing new programs across the region.

In 2023, through a partnership with Don Bosco Cristo Rey High School, we opened a new sports program in Takoma Park, MD – reaching that community for the first time. Launching this program and focusing on diversity outreach allows us to make an even greater impact in the communities we serve and contributes to achieving our strategic goals as outlined in our 2022-2025 strategic plan.

Following our mission of rebuilding KEEN's pre-pandemic programs, we restarted Swim in DC, Fit programs for young adults with disabilities, and Bowling programs in all previously served regions: Montgomery County, Northern Virginia, and Baltimore.

We also built a new partnership with the George Washington University School of Medicine and Health Sciences. GW Medical School students established a KEEN Club at GW Medical School and its members regularly volunteer at KEEN's DC program locations.

None of this would have been possible without the generous support of our donors and partners. Your support allows us to continue offering all our programs completely free of charge. Our programs empower young people with disabilities to believe in themselves. They also change the lives of thousands of volunteers, who get to experience first-hand how our athletes expand their potential in spite of their health challenges.

As we move forward, we remain committed to continuing to expand KEEN's reach within the community. Our goal is to serve every young person with a disability who is looking for friends, fun, and fitness at KEEN.


